#### LETTER FROM GREAT SOUTHERN AREA HEALTH RE DELE-GATE HEALTH SERVICES.

#### 25 November 2022

Dear Delegate community members, MPS residents and families, staff, members of the Delegate Progress Association and Community Consultation Committee,

I am grateful for your feedback and support as we work together to ensure the best health outcomes for the Delegate and Bombala communities.

The purpose of this letter is to provide an update on service delivery from the Delegate MPS. Whilst there are no proposals to close Residential Aged Care in Delegate, it is important to highlight that staffing continues to be a challenge. Currently, there are only two permanent nursing staff employed by the District of the ten Full Time Equivalent (FTE) nursing positions required.

The District is making every effort to recruit nurses to Delegate, Bombala and Cooma with an emphasis on rotation of staff across all three sites to build capacity and experience. Advertised roles are eligible for the new Regional Health incentive scheme which includes opportunities for paid accommodation, postgraduate qualifications, and cash bonuses.

As previously discussed, the focus moving forward will be the implementation of an Assessment and Treatment Care Centre (ATCC). The opening hours for planned care at the ATCC will be 9am to 5pm. Unplanned presentations after hours and weekends will be assessed and managed or referred in the usual way which will include utilisation of virtual Emergency Department support and liaison with NSW Ambulance. The Registered Nurse on duty will provide the appropriate assessment and care and the second nurse on duty will continue to care for the inpatients.

A new ATCC sign will replace the current Emergency Department sign this month to more accurately reflect the service that has operated at Delegate MPS without medical staff on site since 2008.

Along with the ATCC there will be an expansion of Community Health Services. Virtual care appointments are now available at Delegate MPS and new equipment has been purchased to set up a dedicated space for expanded virtual care services. The District is proposing increased specialist nursing and allied health care through a mix of face to face centre-based appointments and virtual care appointments. Discussions continue with General Practice to support virtual GP consultations. Delegate residents can access in-home remote monitoring for a range of conditions (including influenza, COVID-19 and diabetes) and can book in-home and virtual allied health appointments through the Central Intake Line **1800 999 880.** 

The District is investigating the benefits of a dedicated Patient Transport Vehicle to provide non urgent transport between Cooma and Delegate to reduce pressure on ambulance services.

I would like to thank you for your ongoing engagement as we move forward and ask that you continue to engage with us as we implement these changes. Please send any comments or feedback to SNSWLHD-YourFeedback@health.nsw.gov.au

## **Special Rate Variation**

#### This consultation will be open until 11.59pm Sunday 22 January 2023. BACKGROUND

At the Extraordinary Council Meeting on Thursday 24 November 2022, the Council decided to proceed with notifying the Independent Pricing and Regulatory Tribunal (IPART) that Snowy Monaro Regional Council intends to apply for a permanent Special Rate Variation (SRV).

#### What is a Special Rate Variation (SRV) and Rate-Pegging?

Rates increase each year in line with an amount set by the State Government. This amount is calculated every year and is called the 'rate peg'. This is decided by the Independent Pricing and Regulatory Tribunal (IPART).

For the 2023/24 financial year the rate peg applied to Snowy Monaro Regional Council, will be 4.0%. If a council's rate revenue is not enough to maintain service levels, it can apply to IPART to increase overall rate revenue by more than the rate peg. This is known as a Special Rate Variation (SRV). In order to apply for an SRV, councils must demonstrate to the community and IPART that they need the money and have implemented improvements to be more efficient and productive.

#### Why do we need a Special Rate Variation (SRV)?

The rate increases set by the NSW State Government have not kept pace with cost escalations faced by Council in providing services to our community. Like many other NSW councils, SMRC has not generated revenue sufficient to undertake enough investment in community assets.

Our service delivery costs have increased significantly - fuelling our vehicles to repair roads, clean toilets, mow lawns, pay wages, etc - and the costs involved in purchasing materials, hiring contractors and paying suppliers have also increased.

The additional funds received through the SRV will increase the money available to address and correct Council's operating position will enable sufficient funds to be available for renewal and maintenance of assets and the continuation of current service levels.

#### What will happen if the special rate variation is not implemented?

If the SRV is not approved, Council will need to implement service level reductions total

If the SRV is not approved, Council will need to implement service level reductions totalling \$28.8 million over the next ten years. Services will need to be discontinued, roads and buildings will continue to deteriorate, and unsafe facilities will be closed so that necessary funds can be redirected to keep essential infrastructure safe and functional for our community.

#### There are three options for your consideration:

Option 1 – 53% rate increase to be paid in 2023/24. Enables an additional investment of \$64.3 million in asset renewal to stabilise the current infrastructure backlog and to undertake additional renewal and maintenance of our roads and other community assets. Current service levels will be maintained while also progressively improving the operating result ie. financial sustainability.

Option 2 – 55.25% rate increase spread over five years starting from 2023/24. Enables an additional staged investment of \$51.1 million in asset renewal to progressively stabilise the current infrastructure backlog and to undertake additional renewal and maintenance of our roads and other community assets. Over time, current service levels will be maintained while also progressively improving the operating result ie. financial sustainability.

Option 3 - No SRV, Rate Peg Only. Assets and service levels will deteriorate, and the current infrastructure backlog will continue to grow as additional assets deteriorate below satisfactory condition. Council will be required to reduce services and close unsafe facilities.

#### WHAT IS THE IMPACT OF THE SRV ON MY RATES?
